#### Saaya Association of Person with Disabilities (Introduction)

Saaya Association (Organization of Disabled Persons) is registered (VSWA/ICT/562), non-profit and cross disability association, which supports people with disabilities (PWDs), enabling them to realize their full potential through new opportunities, personal choice, and community involvement. The association is working for improving the ultimate status with dignity of people with disabilities. Saaya is focused on Independent Living, Inclusive education, Barrier Free & Right-Based society and access to Justice. It pays special attention to the wellbeing of women and girls with disabilities, as they are subjected to multiple layers of discrimination. The exclusion of persons with disabilities in any country carries heavy financial and social consequences.

Mission of the Saaya is to contribute for improving the social-economic, cultural condition of people with disabilities through the promotion of information, knowledge, skill, awareness and advocacy through the mass media. The 80% staffs of the association are persons with disabilities and contributing on voluntarily basis with gender equality in practice. Our main focus is to work for the betterment of people's attitudes towards persons with disabilities and enhance, promote access to their opportunities in all facets of life. By achieving that, much secure and better living conditions for the persons with disabilities can be made possible. We all interact with others and depend on them in everyday life. They do not have choice and control.

Saaya CIL intends to bring such people especially children/persons/women with disabilities out of their shell of misery into the mainstream life. It also intends to create an environment in Pakistan in general but with special emphasis on Independent Living Centre where People with Disabilities (PWDs) can visit marketplace and other places of public interest without being sneered at or without feeling ashamed of being on a wheelchair or any other assistive gadget.


